THE COOPERATION AGREEMENT BETWEEN UNIVERSITY OF WARMIA AND MAZURY IN OLSZTYN (REPUBLIC OF POLAND) AND KYUNGSUNG UNIVERSITY (REPUBLIC OF KOREA)

University of Warmia and Mazury in Olsztyn (UWM), located in Olsztyn at Oczapowskiego St. 2, 10-719 Olsztyn, Poland, represented by Rector — **Prof. Dr. Ryszard Górecki** and the Kyungsung University, located in Suyeong-ro 309 (Daeyeon-dong), Nam-gu, Busan represented by **Dr. Soo Geun Song**, hereinafter called 'Parties', having an intention to foster international cooperation in education, research and cultural exchange have decided to sign the present Cooperation Agreement (CA). Both institutions seek to develop mutually beneficial programs for their students, faculty, departments, and research institutes within the provision of this CA.

Article 1

The Coordinators and the Faculties participating in the implementation of the Cooperation Agreement shall be, from the side of the UWM:

The Faculty of Mathematics and Computer Science, coordinator prof. Jan Jakóbowski, Dean of the Faculty

and from the Kyungsung University side:

The Faculty of Science, coordinator prof. Oh Sang Kwon, Dean of the Faculty.

Article 2

This CA represents a commitment by both institutions to enter into discussion and negotiation concerning the activities listed below. The two institutions affirm that these discussions would conclude in various agreements that are mutually beneficial. Potential programs and activities between the two institutions may include, but not limited to the following:

- a. Development of joint academic courses and programs in full compliance to the accreditation and professional requirements of both institutions;
- b. Transfer of academic credit-bearing courses based on mutual transparency of course content and faculty qualification;
- c. Exchange of graduate and undergraduate students for study and research:
- d. Exchange of faculty for instruction, research and lectures:
- e. Exchange of educational materials, research projects, publications and library materials; and
- f. Joint conferences, seminars and workshops.

Article 3

The detailed conditions of cooperation, especially the financing mechanisms, plan of exchanges of the academic staff and students of both Parties shall be specified in separate Annexes to this Agreement for each particular case.

Article 4

- a. Proposals, including suggestions not reflected in this CA, may be discussed and implemented on the basis of the specific agreements to be signed by both institutions.
- b. Any alteration to the contents of this Agreement or to particular stages of mutually pursued projects should be concluded in the written form by mutual consent; otherwise it shall be null and void.

Article 5

This CA shall become effective commencing from the date of signatures by both parties and it shall be for a period not to exceed five years. This CA may be amended by the written consent of the parties.

Article 6

The parties may review the CA before the end of the specified period to evaluate the progress and quality of cooperation and may extend it upon the written consent of both parties. If the CA is not renewed, it will conclude at the end of the specified time period, or after activities in progress have concluded.

Article 7

Either party with a minimum of 90 days written notice can terminate this CA. Activities in progress at the time of termination of this CA shall be allowed to conclude unless otherwise agreed by both parties.

Article 8

This CA is to facilitate and develop a mutually beneficial educational relationship. It is not an agency contract.

Article 9

The present Agreement is signed in two copies in the English language, and each Party receive one original.

Article 10

All disputes which might arise from this Agreement shall be resolved by the Rectors, both from the side of the University of Warmia and Mazury in Olsztyn and the Kyungsung University or by the persons authorized by them on the basis of the powers of attorney granted in writing in the process of the conciliation procedure.
