



THE COOPERATION AGREEMENT

BETWEEN
UNIVERSITY OF WARMIA AND MAZURY IN OLSZTYN
(REPUBLIC OF POLAND)
AND
VILNIUS GEDIMINAS TECHNICAL UNIVERSITY
(REPUBLIC OF LITHUANIA)

University of Warmia and Mazury in Olsztyn (UWM), located in Olsztyn, Oczapowskiego St. 2, 10-719 Olsztyn, Poland, and Vilnius Gediminas Technical University (VGTU), located in Vilnius, Saulėtekio al. 11, 10223 Vilnius, Lithuania, hereinafter referred to as the Parties, having an intention to establish the scientific and research cooperation **in the field of Environmental engineering, Measurement engineering and Civil engineering** have decided to sign the present Agreement.

Article 1

The cooperation in research and science as well as education **in the field of Environmental engineering, Measurement engineering and Civil engineering** shall concern:

1. Conducting joint research concerning scientific issues of interest to both Parties, in particular.
2. Exchange of academic and research staff members in studies and research issues.
3. Participation in scientific meetings, symposia and conferences.
4. Arranging bilateral seminars and research meetings.
5. Exchange of expertise between research and academic staff.
6. Publication of science works in periodical of both Parties.
7. Exchange of publications, manuals and coursebooks.
8. Exchange of students.

Article 2

In order to implement the activities of present Agreement, Parties shall designate the Coordinators for its implementation:

- from the side of the UWM – Ph.D. Marek Ogryzek, **Vice Dean Faculty of Geodesy, Geospatial and Civil Engineering**, (e-mail: marek.ogryzek@uwm.edu.pl, tel. +48 89 523 39 77+),
- from the side of the VGTU – Prof. Dr Eimuntas Kazimieras Paršeliūnas, **Professor of the Department of Geodesy and Cadastre** (e-mail: eimuntas.parseliunas@vgtu.lt, tel. +370 5 274 4703).

Any change of the abovementioned persons or their contact details shall be notified within the period of 1 (one) month by the respective Party to the other Party.

Article 3

The present Agreement shall not provide for any mutual financial settlements.

Funding of joint projects and activities under the present Agreement shall be based on separate written agreements between the Parties that shall go as Annexes to this Agreement for each particular case.

Both Parties, by mutual consent, shall seek sources of financing for research programmes that will be executed under this Agreement.

Article 4

This present Agreement shall be in force from the date of signing by both Parties and will be in effect for 5 (five) years. At the end of this period, the outcomes of the cooperation should be assessed and the agreement shall be renewed for additional 5 (five) years in written form by mutual consent of the Parties, unless either party provides written notification of a decision of non-renewal no later than 60 days prior to the expiration date.

Either Party may terminate present agreement by sending a six-month prior written notice to the other Party.

Termination of this agreement shall not affect activities already in progress.

Article 5

The clauses of present Agreement may be revised or changed only upon consent of both Parties. The proposed alterations shall be presented by the Parties and signed by the representatives of both universities.

Present Agreement is not confidential and either Party has a right to publicise a fact of such a cooperation by all means.

The present Agreement is signed in two copies in English language. The Parties shall receive one signed copy each.
